# INDICATIONS:

## DOSAGE AND ADMINISTRATION:

#### Dosage:

One tablet per 80 kg bodyweight daily in two divided doses.

Treatment should be repeated daily until three days after the symptoms have resolved, but in cases of salmonellosis and bacterial pneumonia treatment should be continued for 5 consecutive days. Treatment must not be continued for more than 5 days.
